






Zinc and Lead Market Update



Zinc Metal World Balance


Annual Zinc Refined Consumption




Annual Zinc Refined Production

(zinc content, tonnes in thousands)



Lead daily price and stock level (LME)





Lead Metal World Balance


Annual Lead Refined Consumption



Lead Metal World Balance (cont.)


Annual Lead Refined Production






Russian Zinc Market Overview

(tonnes in thousands)




Zinc Market Structure


Quarterly Refined Zinc Consumption

Refined Zinc Consumption in 4th Quarter of 2008




Refined Zinc Market Structure














